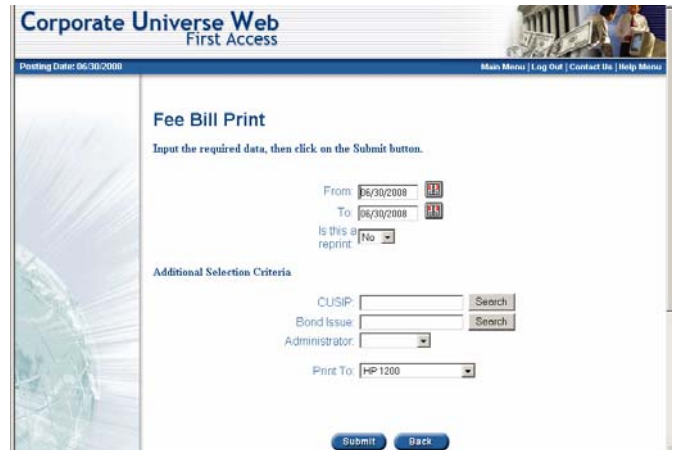

ISS Provides Low Cost Application Recovery & Backup Service Technology permits added protection and security

The best planned scenarios sometimes do not work as intended. Backups are not always performed correctly or the ability to restore computer systems on occasion do not happen in a timely fashion.

In response to a customer request following a mix-up in a recovery situation, ISS added to the Corporate Universe software the capability to create a copy of the customer's database, encrypt the database, compress the database, and transmit it via a secure communication link

to ISS' data center in Philadelphia for storage.

In the event of a recovery situation, ISS maintains computer space on its servers for customers to have the database restored and access it through a secure internet connection to the application software and its database. This service is available until normal operations can be restored.

The cost is minimal, and serves as a fail-safe against problems that can occur because of hardware, software, or organizational problems. Contact your ISS support person for details.
